NOTICE IN TERMS OF SECTION 32(2A) READ WITH SECTION 32(5)(c) OF THE LABOUR RELATIONS ACT, 1995: THE COUNCIL LEVIES COLLECTIVE AGREEMENT OF THE NATIONAL BARGAINING COUNCIL FOR THE PRIVATE SECURITY SECTOR

- 1 I, **Thembelani Waltermade Nxesi**, Minister of Employment and Labour, do hereby in terms of section 32(2A) read with section 32(5)(c) of the Labour Relations Act, 1995, publish a notice in accordance with the provisions of subsection 32(5)(c) inviting representations from the public in response to the National Bargaining Council for the Private Security Sector's application for extension to non parties regarding its Council Levies Collective Agreement which was submitted initially to the Department of Employment and Labour on 21 June 2019. The bargaining council was requested to correct its application for extension to non-parties and the corrected application reached Department on 7 August 2019.




